T/S STATES TO PERFORMED VERIFICATION PROCEDURE AND SEE IF ANY FAULTS COME ACTIVE. PULLED TRUCK OUTSIDE AND PUT INTO A REGEN. MONITORING REGEN. REGEN COMPLETED. PUT UNIT INTO SCR EFFICIENCY TEST.
