- UNIT WOULD NOT SHIFT FROM LOW TO HIGH GEARS. TAIL SHAFT LOCKED IN PLACE. REMOVED RANGE PISTON AIR LINES AND APPLIED SHOP AIR. TRANS UNLOCKED ALLOWING TAIL SHAFT TO SPIN. PULLED SHIFT ABORT COUNTERS. SHIFT LOW AND HIGH ABORTTechlane: (part 2/2)COUNTERS WERE COUNTED HIGH. UNIT WILL NEED RANGE PISTON REPLACED AND HOUSING RESEALED MT REMOVED OLD CPCA AND CLEANED BELL HOUSING. INSTALLED NEW CPCA AND O RING. SECURED HARNESS. REMOVED CLUTCH AND FLYWHEEL.
