1. Warranties and Disclaimers. All Products are sold subject to the applicable manufacturer's or supplier's warranties and disclaimers. Dealer makes no warranties with respect to these items. Dealer warrants items repaired, maintained or serviced by Dealer against defects resulting directly and solely from defects in its workmanship discovered within 60 days or 10,000 miles after such defective workmanship is rendered, whichever first occurs, subject to the provisions hereof. Existence of the defect must be brought to Dealer's attention during the warranty period. Dealer agrees to provide labor and materials at the place where the work was originally performed as needed to repair or replace defects covered by this warranty. THE WARRANTIES AND AGREEMENTS HEREIN SET FORTH ARE EXCLUSIVE AND ARE EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES AND AGREEMENTS, EXPRESS, IMPLIED OR STATUTORY. WITHOUT LIMITING THE GENERALALITY OF THE FOREGOING, DEALER HEREBY DISCLAIMS ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Buyer's sole and exclusive remedies and causes of action are limited to those set forth herein. DEALER SHALL HAVE NO LIABILITY FOR INCIDENTAL, SPECIAL, CONSEQUENTIAL, INDIRECT, PROGRESSIVE OR PUNITIVE DAMAGES OR LOST PROFITS.

2. <u>Payment and Charges</u>. If credit has been extended, payment of parts and service invoices is due in full on the 10th day of the month following the date of the invoice. In the event of nonpayment of any indebtedness within 10 days of when due, Buyer shall pay a late charge of 2% per month computed on the unpaid indebtedness.

3. <u>Storage Fees; Personal Property</u>. Storage charges of \$30.00 per day will apply to each vehicle and/trailer not removed by Buyer from Dealer's premises within 14 days after Dealer notifies Buyer of it availability for pick-up. Dealer shall not be responsible for any property located in or on the vehicle and/or trailer, including cargo or personal property stored therein or thereon.

4. <u>Force Majeure</u>. Dealer shall not be liable for any failure or delay in performance of its obligations related to a "Force Majeure," meaning all circumstances and actions beyond the direct and immediate control of Dealer, including without limitation Acts of God, war and riot, pandemic, intervention of authorities or agencies of government, strikes, lockouts, or other industrial disturbances, shortages or delay in supply of Products from manufacturers or in the supply of fuel, power or component parts.

5. <u>Miscellaneous</u>. Each Order shall be governed by the laws of the Commonwealth of Virginia. Exclusive venue for any actions arising with respect to an Order or any Product shall lie exclusively in the state courts in Botetourt County, Virginia, to whose personal jurisdiction Buyer submits. No modifications or waiver of these Terms and Conditions shall be effective unless in writing. No failure or delay by Dealer in enforcing any of its rights hereunder shall constitute a waiver of such rights either in such instance or any future instances. Buyer shall reimburse Dealer for all costs and expenses, including legal fees, incurred by Dealer in collecting amounts due Dealer by Buyer and/or arising out Buyer's breach hereof. Buyer consents to the use by Dealer and manufacturers of repair order data for analysis purposes or for use in direct marketing and communication support.
